Getting Started

Click to access Well-Being Portal

- Log in at HealthAdvocate.com/Azuria
- From the Health Advocate homepage, click “Well-Being” and select “Rewards” from the drop-down
- Click on both the **Health Screening** and **Personal Health Profile** activities to complete

Step 1: Complete your Health (Biometric) Screening

There are 3 options to complete your screening. Log in to your Health Advocate account to find each one and follow their appropriate steps to schedule and/or download & print documents.

Option 1. Attend an onsite health screening event at your location.

Option 2. Go to a LabCorp facility. Be sure to bring your voucher and Photo ID with you!

Option 3. Go to your Doctor and submit the **Physician Form**. Blood/screening tests must be completed by your doctor between April 1, 2025 and November 30, 2025. *The form must be received by Health Advocate no later than November 30, 2025.*

Step 2: Complete your Personal Health Profile (PHP)

Complete this online survey to assess your current health status and risks. It takes about 10-15 minutes to complete.
